
This is to inform you that Hindustan Petroleum Corporation is one the largest oil refining and marketing public sector undertaking of Govt. of India. HPCL is a **Maharatna Status**, one of the fastest growing Indian company. HPCL is operating state of the art refineries at Mumbai & Vizag along with JV refineries at Bathinda and Mangalore. The company is also establishing state of the art petroleum and petrochemical green field project at Barmer, Rajasthan.

Since last 3 years, we have started marketing of Bulk Bitumen (VG10, VG30 & VG40) in the state of Uttar Pradesh from our Bathinda refinery. We are regularly supplying Bitumen to various government departments like PWD, Rural Engineering Department, Mandi Parishad, UPEIDA led road projects as well as private infra companies operating in the state of UP.

It is to bring to your kind attention that at present, we are able to pitch into approx. 10% of the total bitumen requirement of UP PWD. PWD divisions allocate advance payment for bitumen procurement to Oil Marketing companies, generally in the month of March/April. During the peak demand season, it is felt that due to shortage of bitumen at Oil refineries, construction works suffer and experience delay in execution. We are not able to pitch in during the crisis period because of non-availability of advance funds from various PWD divisions. We assure that we are fully geared up in increasing our footprints to all PWD divisions of UP.


In view of this, we request you to kindly allocate more share of PWD advance payments to HPCL for current Financial Year and FY 2021-22 so that we could be helpful in timely supplying the Bitumen to various PWD divisions thereby timely and uninterrupted execution of road construction works could be ensured.
